In order to improve the quality of your welcome and to make your stay even more enjoyable, we implement one form of income: a tourism tax. This constitutes a small payment made to the proprietor of your accommodation, transferred to the Marne Valley District Borough Council. This payment is entirely dedicated to the tourism services from which you will profit directly: the successful running of the Tourist Office, improved signage, organised events...

### The exemptions :

- Children under 18 years old
- People with a season contract employed in the territory or who are temporarily relocated.
- People benefiting from an emergency accommodation
- People who rent an accommodation where the rent is lower than €1.
